

Great Neck Terrace 2019 Pool Season

Pool Passes - Everyone entering the pool deck needs a valid 2019 pool pass.

Residents:

If you currently have a pool pass, please bring it to the Management Office along with photo ID for validation for the 2019 season.

If you need a pool pass, please come to the Management Office so your photograph can be taken and the pass prepared. Proof of residency and Home Owners Insurance is required.

If you are in arrears, you will not be issued a pool pass until your account is completely up to date.

Guest Passes:

Unused guest passes from 2018 will be accepted in 2019.

The price of a guest pass remains at \$7 each for adults and children (over the age of four). Pass books are available at the Management Office for a discounted price of \$60 for a book of 10 passes. In addition, Twilight passes, to be used after 6 pm daily, are available for \$3 each.

On Saturdays, Sundays and Holidays, guests will be limited to four (4) per unit.

The Management Office is open Monday through Friday from 9:00 a.m. to 5:00 p.m. The Office is located on the side of 2 East Mill Drive, under the green awning.

The AKAM On-Site Management Office will have extended Office hours in May before the pool opens to accommodate residents during non-business hours. These dates will be announced in the 2019 Pool Season memo. Guest passes and booklets may be paid for by a personal check or money order. If you are a shareholder, we can charge it to your account. **Cash will not be accepted under any circumstances.** Tenants must purchase their guest passes in the Management Office.

Guest Policies

All guests must be accompanied by an adult resident or caretaker, 18 years of age or older. When a nanny or caretaker is responsible for the children or seniors under their supervision, the **nanny or caretaker must have a valid Pool Pass** (no charge).

Guests over the age of four (4) years of age require a guest pass. Exceptions are made to this rule when residents are having a party.

In the case of rain, Guests will receive a rain check if they have been at the pool less than three (3) hours.

Great Neck Terrace shareholders who were not issued a pool pass due to a delinquent maintenance account are not permitted as guests.

The resident of the unit will be held liable for any inappropriate behavior or damage by his/her guests.



Pool Hours Summer of 2019

Pool Hours:

Monday through Friday 11:00 a.m. to 8:00 p.m.

Saturday and Sunday 10:00 a.m. to 8:00 p.m.

The pool will be open from 11:00 a.m. to 8:00 p.m. on all summer holidays.



2019 POOL RULES AND REGULATIONS

Pool Deck Area

The pool rules posted within the pool area must be obeyed. If they are not, the resident/guest will be asked to leave.

Use of the pool is not permitted when a lifeguard is not present.

Food and drinks (with the exception of water) will not be permitted in the pool area.

No glass containers of any kind including bottles, drinking glasses, mirrors, baby bottles, thermos bottles and jars are to be brought into the pool area.

No alcohol or drugs are permitted. Persons who appear to be intoxicated or under the influence of drugs are not allowed in the pool area. Anyone found with alcohol or drugs will have their pool pass suspended or revoked.

Smoking in the pool area is not permitted.

Dogs, cats or any other pets (animals) are not permitted in the pool area.

Children under twelve (12) years of age are not permitted into the pool area unless they are accompanied by an adult at all times, including the Kiddie Pool.

All electronic devices must be listened to by headset (including radios, game systems, etc). Consideration for your fellow residents is appreciated when using cell phones at the pool.

Indecent attire is prohibited. Proper attire must be worn when using the pool. Cut-off shorts are not permitted as swimming attire.

The tables and chairs are for everyone's use and may not be reserved or used as storage for personal belongings. Once you leave the facility for the day, you must take your personal belongings with you.

Lockers are available in the shower rooms. You must supply your own lock and remove it and all items at the end of each pool day. GNT is not responsible for any items in the lockers.

All persons are expected to leave the pool area promptly at closing time. When the pool is closed, no one is allowed in the pool area. Anyone caught climbing the fence will have their pool privileges revoked and a fine will be incurred. The Lifeguards on duty have the discretion of restricting entry to the pool area in the case of overcrowding. The Great Neck Terrace Owners Corp., AKAM ASSOCIATES, Inc. and W&L Pool Servicing bear no responsibility for the loss or theft of personal property belonging to any unit owner, resident or guest.

Pool Usage

A parent or adult must physically accompany his/her child in the Kiddie Pool at all times.

Children in diapers are not allowed in the Kiddie Pool, unless the diaper is an approved swimwear type. Children in diapers (of any sort) are not allowed in the main pool.

Children must be four (4) years of age and potty trained to be allowed in the main pool.

Diving is prohibited.

Flotation devices are prohibited except for Coast Guard-approved lifejackets with a crotch strap, swimming aides for children, and noodles. Swimming aides for children such as Swimmies, Arm Bands, and Water Wings are allowed. Inflatable beach balls and sponge balls are allowed in the pool during uncrowded periods and at the discretion of the lifeguard on duty. Floats/rafts may be used during the week, **at the discretion of the lifeguard,** depending on how crowded the pool is. They are not permitted on weekends or holidays.

An adult MUST accompany any child in the pool using a Swimming Aide at all times.

Any excessive noise, dunking, splashing, running, jumping, wrestling, misuse of equipment or other objectionable activities are **NOT** permitted.

The lifeline in the center of the pool marks a drastic decline from shallow to deep water and remains in place at all times. Playing on the lifeline is prohibited.

The lifeguard is provided for everyone's safety and well-being. The GNTOC specifically delegates to the lifeguard the authority to institute any and all rules having to do with safety and health as may be necessary.

No employee shall be reprimanded by any board member, shareholder, tenant, or guest. All complaints shall be made to the Management Office.

Persons with infectious skin disorders or communicable diseases are not allowed in the water.

The Lifeguard, Pool Manager or Superintendent has the right to close the pool down anytime if weather conditions warrant.

*W&L Pool Servicing has the right to remove any person from the pool for any reason in order to maintain a pleasant and safe environment for everyone in the pool area.
